# **General Terms & Conditions**

Entry constitutes full and unconditional acceptance of these Terms and Conditions.

# 1. Eligibility.

a. You must be aged between 12-15 to enter this competition in years eight, nine and ten at secondary school.

b. If teachers are entering pupils from their class, they must be part of a registered secondary school to enter. c. Open to UK or Republic of Ireland residents in secondary schools across Year's 8-10. Residents of Northern Ireland, the Channel Islands and Isle of Man are included. Not open to employees of BIC, its agencies or anyone else professionally associated with this competition.

d. Each individual participant may register only once, secondary schools can enter an open number of individual pupils, but not the same pupil twice. a. You must handwrite your answer to the question 'What would waking up in a world without words be like?' on plain A4 paper. All entries must detail the entrant's name, age, academic year, teacher's name, school and contact details. Any entries that are not handwritten will be classed as void. Entries should be posted to BIC's Creative Writing Competition, C/O Lucre, Broadway Studios, 20 Hammersmith Broadway, London, W6 7AF and be sent before the closing date of 6th June 2016. To be eligible entries must be no longer than 500 words and include a separate piece of paper (attached using a paper clip) detailing the pupil's name, age, year, teacher's name, signature, school and contact details (address, telephone number and email address).
